## 1. Hermeneutics Literature



### 张江 (ZHANG Jiang)

中国社会科学院大学教授、博士生导师，中国社会科学院文学与阐释学研究中心理事长，中国社会科学院大学阐释学高等研究院院长，中国文学批评研究会会长，《中国文学批评》主编。曾任中国社会科学院副院长、中国社会科学杂志社总编辑，《文学评论》主编。长期从事文艺理论和文学批评研究工作，在中西文艺理论及中国当代诗学研究领域尤有建树，先后在《中国社会科学》《文艺研究》

《文学评论》《哲学研究》等权威学术期刊发表专业论文数十篇，部分论文被译成英文、法文、意大利文、俄文等在国外著名学术期刊发表。他提出的“强制阐释论”“公共阐释论”“阐释逻辑论”等不仅在中国文艺理论界产生重要影响，在国际学术界也引发热烈讨论，得到德国、英国、美国、意大利、法国等国家历史学、哲学、文艺理论界专家学者的广泛关注和认可。

While serving as a Ph.D. supervisor of UCASS, Prof. ZHANG Jiang is also President of the Literature and Hermeneutics Research Center (approved and accredited by CASS), the Institute of Advanced Studies in Hermeneutics of UCASS, and the Chinese Society for Literary Criticism, as well as Editor-in-Chief of the *Chinese Journal of Literary Criticism*. He used to serve as Vice President of CASS and Editor-in-Chief of Social Sciences in China Press, and *Literary Review*, with long-term dedication to research on scientific theory of literature and literary criticism. Particularly well accomplished in the field of Chinese and Western scientific theory of literature and Chinese contemporary poetics, Prof. Zhang has published dozens of professional papers in authoritative academic journals, such as *Social Sciences in China*, *Literature and Art Studies*, *Literary Review*, and *Philosophical Researches*. Some of his works have been translated into English, French, Italian, Russian among other languages for publication in renowned academic journals overseas. His theories on compulsory hermeneutic, public hermeneutic and hermeneutic logic have not only made their impact on literary theories in China, but also triggered heated discussions within the international academic community, drawing extensive attention and recognition from experts and scholars of historical, philosophical and literary theory backgrounds in Germany, the United Kingdom, the United States, Italy and France.

审专家、国家出版基金评审专家,全国马列文论研究会会长和中国古代文学理论学会副会长、中国太湖文化论坛副主席、中国文学理论学会常务理事等。研究方向为文艺学、中国古代文论、中国古代文学、文化批评等。2008年获国务院政府特殊津贴,2008年获中华人民共和国教育部、国务院学位委员会颁发的“全国优秀博士学位论文指导教师”荣誉证书。主持、承担过国家社科基金重点课题和中国社会科学院院重大课题、教育部重点课题、研究所重点课题等的研究工作,发表学术论文200余篇,出版学术著作10余种,主编学术论著10余种(部),科研成果多次获奖。现担任国家社科基金重大项目“中国古代文体观念文献整理与研究”首席专家。

As a Ph.D. supervisor of UCASS, Prof. DANG Shengyuan also serves as editorial board member for multiple academic journals, including *Literary Review*, *Journal of Graduate School of Chinese Academy of Social Sciences*, *Chinese Culture Research*, *Journal of Northwest University*, and the Institute of Literature, CASS(1999-2010), Party Committee Secretary and Deputy Director of the Institute of Foreign Literature, CASS(2010-2019) and Deputy Editor-in-Chief for *Literary Review* (2004-2010), alongside his concurrent roles as expert reviewer of the National Social Science Foundation of China on disciplinary planning and the National Publication Foundation, as well as President of the National Society of Marxist and Leninist Art and Literary Criticism, Vice President of the Chinese Society of Ancient Literary Theory, Vice Chair of the Taihu World Cultural Forum, and Executive Council Member of the Chinese Association for Literary Theory. His research interests include literature and art, ancient Chinese literary theory, ancient Chinese literature, and cultural criticism. Recognized as an expert in the Special Allowance Program of the State Council and by the honorary certificate of "National Outstanding Doctoral Dissertation Supervisor" jointly awarded by the Ministry of Education of the People's Republic of China and the State Council Academic Degrees Committee in 2008, Prof. Dang has led and undertaken multiple major and key research projects of the National Social Science Foundation of China, Chinese Academy of Social Sciences, Ministry of Education, and research institutes. He has published more than 200 academic papers, 10-plus academic works, and above 10 edited academic treatises, with

various awards in recognition of his research outcomes. He is currently the chief expert of a major project under the National Social Science Foundation of China: "Literature Compilation and Study of Stylistic Concepts in Ancient Chinese Literature".

As a Ph.D. supervisor of UCASS, Prof.ZHANG Xian also serves as the Director of Literature Department of Social Sciences in China Press, Executive Deputy Editor of Chinese Literary Criticism. He is also the Vice President of the Chinese Society of Popular Culture, the secretary general of the Chinese Literary Criticism Society, and the Vice President and Secretary General of the New Media Culture Research Institute of the Chinese and Foreign Literary Theory Society. His research interests are literary theory, hermeneutics and network culture.

*Silk Roads* (丝绸之路文化研究) 刊物主编及多家中、美、俄和蒙古等学术刊物编委。研究方向为中国少数民族文学、民俗学。有著作、论文、译著等70余种, 以多种文字在中国、美国、日本、俄罗斯、马来西亚、越南、蒙古等国刊发。

Professor CHAO Gejin is a member of the Academic Committee of the Chinese Academy of Social Sciences, professor and doctoral supervisor at University of the Chinese Academy of Social Sciences. Additionally, he is chairing both the China Ethnic Literature Society (CELS) and the International Society for Epic Studies (ISES) as President and the Popular Culture Society of China (PCSC) as Vice President. Recognized as a UNESCO expert on intangible cultural heritage, Prof. Chao used to act as President of the International Council for Philosophy and Human Sciences (CIPSH, 2014-2020) and the China Folklore Society (CFS, 2010-2018), among other titles. He is also the Editor-in-Chief for *Studies on Ethnic Literature*, *Cultural Studies along the Silk Roads* and editorial board member for several academic journals from China, the United States, Russia and Mongolia. His area of research interests includes Chinese literature of ethnic minorities and folklore. Having published more than 70 books, papers and translated publications, Prof. Chao's works have already been released in various languages across China, the United States, Japan, Russia, Malaysia, Vietnam, Mongolia, among other countries.

As a Ph.D. supervisor of UCASS, Prof. BU Xianqun, Doctor of History, also serves as the Director of Institute of Ancient History, Chinese Academy of Social Sciences(CASS), member of the professional Qualification Evaluation Committee of Department of History, Chinese Academy of Social Sciences (CASS); member of History Subject Appraisal Group of Academic Degrees Committee of The State Council; Vice President of Chinese Historical Society; President of Chinese History Research Association of Qin and Han Dynasties; Vice president of China Toponym Heritage Culture Protection and Promotion Association; Expert of the Subject Evaluation Group of national Social Science Fund; Member of the Steering Group of Chinese local Chronicles and Councilmember of International Federation of Confucianism, etc. He has published the Bureaucratic System of the Qin and Han Dynasties, The Educational History of The Wei ,Jin and Southern and Northern Dynasties in China (co-authored), A Concise Chinese History Reader (presided over), A Concise Knowledge Manual of Chinese History (presided over), Corruption and Anti-corruption in Chinese History (chief editor, In 2017, it was nominated for the Fourth Chinese Government Publication Award), chief writer of 100-episode documentary General

History of China and five-volume General History of China (nominated for the fourth Chinese Government Publication Award in 2017), Xi Jinping's Historical View of Governance in the New Era (chief editor), Talking History with Leading Cadres, etc. He has published more than 100 papers in *Chinese social Sciences*, *Historical Studies*, *Chinese History Studies*, *Literature, History and Philosophy*, *History Monthly*, *Qiushi*, *People's Daily*, *Guangming Daily*, *Learning Times*, and other newspapers and periodicals



## 王震中 (WANG Zhenzhong)

中国社会科学院学部委员、中国社会科学院历史学部副主任、博士生导师，中国社会科学院大学特聘教授。曾担任中国社会科学院历史研究所副所长、历史所学位委员会主任、中国社科院研究生院历史系主任、第十三届全国政协委员。社会兼职：担任中国殷商文化学会会长、国家广播电影电视总局电影审查委员会委员、国家教材

委员会专家委员会委员等。主要从事史前文化、先秦史、国家与文明起源史、夏商城市史、早期文明史等方向的研究，在《历史研究》、《中国史研究》、《Social Sciences in China》、《中国社会科学》等期刊发表论文100余篇，著有著作10余部，其主要著作有《中国文明起源的比较研究》、《中国古代国家的起源与王权的形成》、《商代都邑》、《商族起源与先商社会变迁》、《中国古代文明的探索》等。

Professor WANG Zhenzhong is a member of the Academic Committee of the Chinese Academy of Social Sciences, Deputy Director of the History Department of the Chinese Academy of Social Sciences, doctoral supervisor, and distinguished professor at University of the Chinese Academy of Social Sciences. He has previously served as Deputy Director of the Institute of History at the Chinese Academy of Social Sciences, Director of the Degree Committee of the Institute of History, Director of the History Department of the Graduate School of the Chinese Academy of Social Sciences, and a member of the 13th National Committee of the Chinese People's Political Consultative Conference. His other social positions include serving as the President of the Chinese Yin-Shang Culture Society, a member of the Film Review Committee of the State Administration of Radio, Film, and Television, and a member of the Expert Committee of the National Textbook Committee. Wang Zhenzhong's research primarily focuses on prehistoric culture, early Chinese history, the origins of states and civilizations, the history of Xia and Shang cities, and the early history of civilizations. He has published over 100 papers in journals such as "Historical Research," "Chinese Historical Research," "Social Sciences in China," and "Chinese Social Sciences," and has authored more than 10 books. His major works include "A Comparative

*Study of the Origins of Chinese Civilization," "The Origins of Ancient Chinese States and the Formation of Royal Power," "Cities in the Shang Dynasty," "The Origins of the Shang People and the Social Changes in Early Shang Society," and "Exploration of Ancient Chinese Civilization."*

Professor ZHANG Yuyan is a Senior Fellow and former Director of Institute of World Economics and Politics (IWEP), Chinese Academy of Social Sciences (CASS), Chief Expert of National Institute for Global Strategy, CASS. His main academic interests include institutional economics and international political economy. He authored such books as *Economic Development and the Choice of Institutions* (1992), *International Economic Politics* (2008), *The Sources of American Conduct* (2015) and *The Path of China's Peaceful Development* (2017), etc.



## 高海红 (GAO Haihong)

中国社会科学院大学教授、博士生导师。中国社会科学院二级研究员，世界经济与政治研究所国际金融研究中心主任，中国社会科学院创新工程首席研究员，国务院“政府特殊津贴”荣誉专家。兼任中国金融学会常务理事、中国世界经济学会常务理事、中国国际金融学会理事、官方货币和金融机构论坛(OMFIF) 顾问委员、二十国集团(G20) 智库二十(T20) 国际金融工作组联合

主席。曾任东亚思想库网络(NEAT) 中国工作组首席经济学家、中央财经大学金融学院学术委员、外交学院兼职教授。重点研究领域为国际金融和货币、汇率与资本流动、区域货币合作。主持开展多项国家级课题。论文“最优货币区：对东亚国家的检验”(《世界经济》2007年7期)获第八届中国社会科学院优秀科研成果三等奖(2014年)。论文“从东亚货币危机看汇率制度选择”(《管理世界》1998年6期)获第三届中国社会科学院优秀科研成果三等奖(2000)与第三届世界经济与政治研究所优秀科研成果一等奖(2000)。论文“货币可兑现性的条件和国际比较”(《改革》1995年2期)获第三届中国社会科学院青年优秀科研成果二等奖(2000)。

As a Ph.D. supervisor of UCASS, Prof.GAO Haihong is an expert recognized by the Special Allowance Program of the State Council. In addition to her roles as Research Fellow II of CASS and Principle Investigator of CASS Innovation Project, Prof. Gao is also Director of the Research Center for International Finance affiliated to the Institute of World Economics and Politics, alongside her various concurrent positions: Executive Council Member of the China Society for Finance and Banking (CSFB) and the China Society of World Economics(CSWE), Council Member of the China International Finance Society(CIFS), Advisory Member of the Official Monetary and Financial Institutions Forum(OMFIF) and Co-Chair of the International Finance Working Group under the T20 Think Tanks of the Group of Twenty(G20). She used to serve as Chief Economist of China Working Group of the Network of East Asian Think Tanks(NEAT), Academic Member of the School of Finance of the Central University of Finance and Economics, and Adjunct Professor of China Foreign Affairs University. Her main research interests include international finance and currency, exchange rates and capital flows, and regional monetary cooperation. She has by far led multiple national research projects. Her paper titling "*Optimal Currency Area: An Empirical Study on Selected East Asian Economies*" (*The Journal of World Economy*, Volume 7, 2007) was awarded the third-tier prize of the Eighth CASS Award for Outstanding Scientific Research Achievements (2014). Another paper titling "*The Choice of Exchange Rate Regime in the context of East Asian*

*Currency Crisis*" (Management World, Volume 6,1998) was honored with the third-tier prize for the Third CASS Award for Outstanding Scientific Research Achievements (2000) and the first-tier prize of IWEP Award for Outstanding Scientific Research Achievements (2000). Her paper titling "*Conditions for Currency Convertibility and International Comparison*" (Reform, Volume 2,1995) won the second-tier prize of the Third CASS Award for Young Scholars Outstanding Scientific Research Achievements (2000).



## 张斌 (ZHANG Bin)

中国社会科学院大学教授、博士生导师，经济学博士。中国社会科学院世界经济与政治研究所副所长并兼任世界经济预测与政策模拟实验室首席专家，社科基金政策咨询点项目主持人。研究领域是中国和全球宏观经济，重点研究的问题包括中国经济结构转型、中国宏观经济和金融市场、人民币汇率和外汇管理、全球宏观经济等。曾获得浦山优秀论文奖，国务院特殊津贴，入选百千万人才工程。

As a Ph.D. supervisor of UCASS, Prof. ZHANG Bin is currently serving as Deputy Director of the Institute of World Economics and Politics, CASS, with a doctorate in economics. Prof. Zhang also has multiple concurrent roles, such as Chief Expert of the Laboratory of World Economic Forecasting and Policy Simulation and Chair of Policy Enquiry Sites Project of National Social Science Foundation of China. His research interests include Chinese and global macroeconomics, with a particular focus on China's economic structural transformation, macro economy and financial market, RMB exchange rate and foreign exchange management, and global macro economy. He has been acknowledged by the Pu Shan Award for Distinguished Paper, the Special Allowance Program of the State Council and the New Century Hundred-Thousand-Ten Thousand Talents Project.



## 徐奇渊 (XU Qiyuan)

中国社会科学院大学教授，博士生导师，经济学博士。中国社科院世界经济与政治研究所副所长，国际金融研究中心副主任。研究领域为国际金融学、开放条件下的中国宏观经济。2011年，博士学位论文被教育部和国务院学位委员会评为“全国优秀博士学位论文”。被评为2016-2020年度中国社会科学院科研岗位先进个人，2021年获“浦山世界经济学优秀论文奖”之政策研究奖。在

学术期刊发表论文60多篇，出版专著10部、译著2部。政策研究方面，1部专著被评为2020年度中国社会科学出版社“优秀国家智库报告”。获得中国社会科学院优秀信息对策奖一等奖2次，三等奖8次。在国内外主流财经媒体发表300多篇评论文章。

As a Ph.D. supervisor of UCASS, Prof. XU Qiyuan, Doctor of Economics, also serves as Deputy Director of Institute of World Economics and Politics, Chinese Academy of Social Sciences (CASS), and Deputy Director of Center for International Finance studies. His research fields are international finance and Chinese macroeconomics under the condition of opening up. In 2011, his doctoral dissertation was awarded "National Excellent Doctoral Dissertation" by the Ministry of Education and Academic Degrees Committee of The State Council. He was awarded the 2016-2020 Advanced Individual in Scientific Research of the Chinese Academy of Social Sciences. In 2021, he was awarded the Policy Research Prize of "PU Shan Excellent Paper Award in World Economics". He has published more than 60 papers in academic journals, 10 monographs, and 2 translated books. In terms of policy research, one monograph was rated as "Excellent National Think Tank Report" by China Social Sciences Press in 2020. He has won the first prize of the Excellent Information Strategy Award of the Chinese Academy of Social Sciences twice and the third prize 8 times. Prof. Xu has published more than 300 commentary articles in mainstream financial media at home and abroad.

长期从事国际经济学领域研究和教学工作，参与了多项财政部、发改委等组织的政策研究。出版学术专著5部，代表性论著包括《中国内需变动影响出口的机制与政策应对——企业动态视角》（独著）、《贸易开放、要素

再配置及其经济效应》（独著）等。在本学科顶级和权威期刊发表学术论文14篇。主持完成国家自然科学基金、社科基金项目4项，中国社科院重大创新工程项目1项，创新工程项目3项。主持完成中国社会科学院学科“登封战略”重点学科（国际投资学）建设。长期承担社科院大学博、硕士研究生的《国际贸易学》、《高级国际经济学》教学任务。曾多次获中国社会科学院优秀信息对策特等奖、一等奖；曾获国家发展和改革委员会优秀科研成果一等奖，商务部商务发展研究成果奖一等奖等。

He has been engaged in research and teaching in the field of international economics for a long time. He has participated in policy research organized by the Ministry of Finance, the National Development and Reform Commission, etc. He has published five academic monographs, including "The Mechanism and Policy Responses of China's Domestic Demand Fluctuations on Export: A Dynamic Perspective of Enterprises" (sole author) and "Trade Opening, Factor Reallocation and Its Economic Effects" (sole author), etc. He has published 14 academic papers in top and authoritative journals in this field. He has completed 4 projects funded by the National Natural Science Foundation of China and the Social Science Foundation of China, 1 major innovation project of the Chinese Academy of Social Sciences, and 3 innovation projects. He has completed the construction of the key discipline "International Investment" of the Chinese Academy of Social Sciences, which is a priority discipline. He has also been responsible for teaching the courses "International Trade Theory" and "Advanced International Economics" to doctoral and master's students at the University of China Academy of Social Sciences. He has received several special awards for outstanding information and countermeasures from the Chinese Academy of Social Sciences, including the first and second prizes.
